Tax Day 2012


National Priorities Project looks at where the federal government spent your income taxes—down to the penny.

On April 17, 2012, your 2011 federal income tax return is due to the IRS. Where did the federal government spend your income taxes during fiscal year 2011?

Federal income tax revenues totaled around \$1.13 trillion in fiscal 2011, and this chart shows exactly where the federal government spent each one of those dollars:

When you pay federal income taxes, the U.S. Treasury designates that money as “federal funds.” That means Congress and the president can spend that money on any government activity—and the chart above shows how they chose to spend federal funds in 2011. This chart does not include your payroll taxes, also called Social Security and Medicare taxes, which are designated as “trust funds” and can only be used by the Treasury to fund those two programs. But as you

can see from the chart above, some federal funds are also used to pay for Social Security and Medicare.

Thanks for Your Business

Some people think the federal government should give them a receipt for their income taxes in order to show where all that money was spent. While you may not get a receipt from the IRS any time soon, National Priorities Project went ahead and wrote one up. This receipt shows where \$2,654 in income taxes was spent by the government in fiscal 2011. That's an estimate of the taxes paid by a single person earning around \$30,000 annually.
